

## Highlights of Developments in Q3 2021

- Net assets of UCITS and AIFs grew 1.7% in Q3 2021, reaching EUR 20.8 trillion.** UCITS net assets increased by 2%, whereas the net assets of AIFs grew by 1.3%. Net asset growth was limited in Q3 2021, as global stock markets remained relatively flat over the quarter.
- UCITS and AIFs attracted a total of EUR 200 billion in net inflows in Q3 2020.** Net sales of UCITS amounted to EUR 179 billion, down from EUR 210 billion in Q2 2021. AIFs attracted EUR 21 billion in net new money over the quarter, compared to EUR 18 billion in Q2 2021.









- Net sales of equity funds slowed down, whereas net inflows into bond and multi-asset funds picked up.** After having recorded exceptionally high net inflows over the past three quarters, net sales of equity funds slowed down in Q3 2020, against the backdrop of more volatile stock markets. Still, the net sales volume remained robust. At the same time, investors increased their purchases of bond and multi-asset funds, which enabled them to diversify their investment portfolios.
- Money market funds (MMFs) continued their net outflows (EUR 10 billion).** Investors continued to reduce their net holdings of MMFs in Q3 2021, shifting their investments towards long-term funds.



- The first half of 2021 was marked by a significant reallocation of savings by European households towards investment funds (see chart on page 5).** Following the already strong fund purchases in Q1 2021 (EUR 56 billion), purchases by European households rose to EUR 61 billion in Q2 2021). German and Italian households were the largest retail investors in Q2 2021, but households in Spain, Belgium and the Nordic countries also bought substantial amounts of investment funds.

### *Net Sales of UCITS by Investment Type*














### *Net Sales of AIFs by Investment Type*





### *Net Assets of UCITS and AIFs by Investment Type*




## Ownership of Investment Funds in Europe<sup>2</sup>

(EUR billions and share of total, end Q2 2021)**




**Investment Fund Ownership by Country
