




Worldwide Regulated Open-end Fund Assets and Flows

Trends in the Third Quarter of 2024



Brussels, December 17, 2024

Worldwide regulated open-end fund assets increased by 2% in euro terms to EUR 71.99 trillion in Q3 2024.¹ Worldwide investment funds registered net inflows of EUR 825 billion, compared to EUR 751 billion in Q2 2024.



¹ The information presented in this report was compiled by EFAMA and the Investment Company Institute (ICI) on behalf of the International Investment Funds Association (IIFA), the organization of national investment fund associations. Statistics from 46 countries are included in this report. All data presented in this report include funds of funds, exchange-traded funds and institutional funds.

Worldwide investment fund net assets measured in U.S. dollars increased to USD 80.6 trillion at the end of Q3 2024. This represented a 6.7% rise from the previous quarter. The following two graphs compare the net asset growth in the six largest countries/regions.




On a euro-denominated basis, worldwide equity fund assets increased by 2.6%, reaching EUR 32.8 trillion at the end of Q3 2024. Bond fund assets rose by 2%, totalling EUR 13.2 trillion. Multi-asset funds recorded growth of 1.2%, reaching EUR 10.6 trillion. Money market funds (MMFs) grew slightly by 0.8% to reach EUR 10 trillion. Real estate funds and other funds also registered increases in net assets of 0.7% and 2.7%, respectively. Every fund category saw an increase in net assets during the quarter.



At the end of Q3 2024, equity funds accounted for 45.6% of worldwide regulated open-end fund net assets. The share of bond funds amounted to 18.3%, and the asset share of multi-asset funds was 14.8%. MMF assets represented 13.9% of the worldwide total.





Looking at the breakdown of worldwide investment fund net assets per domicile at the end of Q3 2024, the United States held the largest global market share, with 52%. Europe ranked second, with a market share of 30.6%. China (5%), Canada (3.2%), Brazil (3.1%), Japan (3%), Republic of Korea (1%), India (1%), Chinese Taipei (0.4%) and South Africa (0.3%) follow in this ranking.





Overall, five European countries ranked among the top ten largest fund domiciles in the world: Luxembourg (with 7.9% of worldwide investment fund assets), Ireland (6.5%), Germany (3.9%), France (3.4%), and the United Kingdom (2.9%).

Net sales of worldwide regulated open-end funds reached EUR 825 billion in Q3 2024, compared to EUR 751 billion in the previous quarter. Long-term funds recorded net inflows of EUR 458 billion, down from EUR 505 billion in Q2 2024. Net sales of MMFs amounted to EUR 367 billion, up from EUR 247 billion in Q2 2024.



Globally, equity funds saw net inflows of EUR 230 billion, up from EUR 116 billion in Q2 2024. Bond funds recorded net inflows of EUR 224 billion, down from EUR 395 billion in the previous quarter. In contrast, multi-asset funds continued to experience net outflows, totalling EUR 63 billion, marking the tenth consecutive quarter of negative net sales.

ETFs registered net inflows of EUR 461 billion in Q3 2024, an increase from EUR 292 billion in Q2 2024. The inflows in Q3 were primarily driven by the United States (EUR 272 billion), followed by China (EUR 83 billion) and Ireland (EUR 52 billion).



In Q3 2024, all major regions continued to experience net inflows, following a similar trend as in Q2 2024. Europe recorded net inflows of EUR 182 billion, up from EUR 151 billion in Q2 2024. Net inflows were primarily driven by Ireland (EUR 134 billion). Most European countries saw positive inflows over the quarter, except for the UK, which experienced significant net outflows of EUR 16 billion, and Germany, which recorded modest outflows of EUR 1 billion.

The United States recorded net inflows of EUR 486 billion in Q3 2024, a significant increase from EUR 196 billion in Q2 2024. This growth was mainly fuelled by robust net inflows into money market and bond funds.

The Asia-Pacific region² recorded net inflows of EUR 108 billion in Q3 2024, down sharply from EUR 340 billion in Q2 2024. Inflows were led by Japan (EUR 31 billion), followed by India (EUR 25 billion). In contrast, China saw modest net sales of EUR 14 billion, a steep decline from EUR 249 billion in Q2 2024. This drop was largely due to strong net outflows from bond funds and MMFs.

The Americas³ registered net inflows of EUR 49 billion in Q3 2024, down from EUR 65 billion in Q2 2024. Canada saw net inflows of EUR 23 billion, compared to EUR 15 billion in Q2 2024. Brazil registered positive net sales of EUR 9 billion, down from EUR 32 billion in Q2 2024.



European long-term funds recorded net inflows of EUR 85 billion in Q3 2024, compared to EUR 118 billion in Q2 2024. All fund categories registered positive inflows during the quarter. Bond funds were the top-selling category in Q3 2024, attracting net sales of EUR 50 billion, although this was a decrease compared to EUR 76 billion in Q2 2024. Equity funds registered net inflows of EUR 22 billion in Q3 2024,

down from EUR 26 billion in Q2 2024. Multi-asset funds saw modest net inflows, recording the same level of net sales as in Q2 2024 (EUR 6 billion).


European MMFs saw net inflows of EUR 96 billion in Q3 2024, a substantial rise from EUR 32 billion in Q2 2024.

In the United States, long-term open-end funds reported net inflows of EUR 188 billion in Q3 2024, up from EUR 99 billion in Q2 2024. Equity funds saw net inflows of EUR 62 billion in Q3, up from EUR 25 billion in Q2 2024. Bond funds recorded net inflows of EUR 163 billion, compared to EUR 114 billion in Q2 2024. On the other hand, multi-asset funds experienced net outflows of EUR 41 billion in Q3 2024, slightly higher than the EUR 41 billion in net outflows recorded in Q2 2024.

US MMFs recorded net inflows of EUR 297 billion, a significant rise compared to EUR 97 billion in Q2 2024.

In Q3 2024, long-term funds in the Asia-Pacific region recorded net inflows of EUR 137 billion, primarily driven by equity fund flows, with China (EUR 84 billion) and Japan (EUR 34 billion) leading the inflows. Bond funds registered net outflows of EUR 25 billion, compared to net inflows of EUR 159 billion in Q2 2024. Multi-asset funds also recorded net outflows of EUR 11 billion, compared to net outflows of EUR 5 billion in Q2 2024.

MMFs in the Asia-Pacific registered net outflows of EUR 29 billion in Q3 2024, primarily driven by outflows from China (EUR 20 billion), Republic of Korea (EUR 8 billion), and Japan (EUR 5 billion). This marked a reversal from the net inflows of EUR 98 billion seen in Q2 2024.
