




## Highlights of Developments in Q3 2024

- UCITS and AIF net assets grew by 2.7% in Q3 2024, with UCITS increasing by 3.2% and AIFs by 1.8%.
- UCITS and AIFs saw robust net inflows of EUR 179 billion, up from EUR 142 billion in Q2 2024. Net sales of UCITS reached EUR 174 billion, whereas AIFs registered EUR 5 billion in net inflows. Over the first three quarters of 2024, net inflows into UCITS and AIFs totalled EUR 401 billion and EUR 27 billion, respectively.











- Long-term funds registered net inflows of EUR 83 billion, down from EUR 110 billion in Q2 2024. Bond funds saw net inflows of EUR 49 billion, a decrease from EUR 77 billion in Q2 2024. Equity funds attracted net inflows of EUR 21 billion, slightly down from EUR 25 billion in Q2 2024. Multi-asset funds saw net inflows of EUR 6 billion. Net sales of long-term funds declined as investor confidence was influenced by uncertainty surrounding the interest rate cycle, the upcoming U.S. elections, and fiscal measures to address budget deficits in several countries.
- Money market funds saw significant net inflows of EUR 96 billion, compared to EUR 32 billion in Q2 2024, confirming their status as a 'safe haven' investment option in volatile times.



- ETFs maintained their positive momentum. UCITS ETFs recorded net sales of EUR 57 billion, similar to the net inflows of EUR 58 billion registered in Q2 2024. ETFs have seen very strong net sales so far this year, registering net inflows of EUR 170 billion over the first three quarters of 2024, already higher than the total ETF net sales for the entire year 2023 (EUR 169 billion).
- SFDR Article 9 funds continued to experience net outflows. This marks the third consecutive quarter of net outflows for Article 9 funds. LT Article 8 funds registered net inflows of EUR 37.5 billion in Q3 2024, whereas LT Article 9 funds recorded net outflows of EUR 3.2 billion, compared to net outflows of EUR 6.9 billion in Q2 2024.
- European households maintained their appetite for investment funds in Q2 2024, with net fund acquisitions reaching EUR 62 billion, up from EUR 42 billion in Q1 2024. Mainly German, French, Italian, and Spanish households bought funds, but positive net acquisitions were recorded in almost all EU countries.

### Net Sales of UCITS by Investment Type






### Net Sales of AIFs by Investment Type







### Net Assets of UCITS and AIFs by Investment Type










## The European Investment Fund Industry Net Sales of SFDR Article 8 and 9 UCITS<sup>2</sup>




